Zadropa Act: At Long Last Congress Does the Right Thing by 9/11 First Responders

Finally, following a year of debate, political posturing, and increasing public pressure, the U.S. Congress approved an extension of the Zadropa 9/11 Health and Compensation Act as a part of an omnibus spending bill, shortly thereafter President Barack Obama signed the bill into law.

The Zadropa measure extends the World Trade Center Health Program for 75 years at a cost of \$3.5 billion and renews the Victims' Compensation Fund for five years and fully funds it at \$4.6 billion.

The serious impact of attacks of 9/11 on the health of New Yorkers was both immediate and long-term. Those affected include not only first responders and emergency personnel, but also schoolchildren and residents of the entire lower Manhattan region. Over 13,000 WTC responders are sick and receiving treatment. Nearly 53,000 responders are enrolled in medical monitoring, and approximately 71,000 individuals are enrolled in the WTC Health Registry, indicating that they were exposed to the toxins and that their health could be negatively impacted.

The toxins these individuals were exposed to have resulted in serious health complications including respiratory, gastrointestinal, and mental health conditions.

BALCONY has long been an advocate of 9/11 responders and others whose health was negatively affected by their proximity to Ground Zero.

In 2006 **BALCONY** forewarned of the potential toxic cancer danger when we produced two informative PSA's warning residents and workers at the World Trade Center site to register for possible workers compensation. The spots, which aired on New York TV stations, featured Actress Sigourney Weaver and Jim Simpson, co-owners of the Flea Theater, and a Spanish version featured the late Jose Torres, former light heavyweight Champion (click below to watch!).

BALCONY will continue to advocate on behalf of affected individuals and support legislation that seeks to provide them with the medical and financial assistance they need and deserve. **BALCONY** member Mt. Sinai's Selikoff Centers for Occupational Health has been a key participant in first-responder screening and treatment.

Responses to the Zadroga Victory

Congresswoman Carolyn B. Maloney (D-NY), the lead sponsor of the House bill, stated "Never again will survivors and responders be forced to walk the halls of Congress, begging for their health care. Congress has taken bipartisan action to do right by the heroes of 9/11."

THE BALCONY INFRASTRUCTURE INITIATIVE GATEWAY BREAKFAST FORUM

On Friday November 13, 2015 the **Business and Labor Coalition of New York (BALCONY) Infrastructure Initiative** hosted a "**Gateway Project Breakfast Forum**" that featured **Keynote Speaker Congressman Jerrold Nadler (D-NY)** and other experts and advocates to discuss and build support and advocacy for the Gateway project and infrastructure investment in New York and New Jersey. The forum came just one day after a momentous announcement by New York Governor Andrew Cuomo, New Jersey Governor Chris Christie, Senator Charles Schumer (D-NY), Senator Cory Booker (D-NJ) and U.S. Secretary of Transportation Anthony Foxx regarding the creation of a **Gateway Development Corporation** to oversee the 10 year \$20 billion Gateway project. The Gateway Development Corporation will see the cost of the project split 50/50 between the states and the Federal Government and Amtrak under the direction of the Port Authority of New York and New Jersey.

Task Force Reports Common Core Let Students and Teachers Down



Chaired by Richard Parsons, the Common Core Task force was created by Governor Cuomo and was charged with reviewing and reform the controversial Common Core State Standards. Citing "disruption and anxiety" caused by the flawed rollout of the program the Governor asked the task force to engage parents, teachers, students, and others to hear from them what is, and is not, working; review the Standards, the related curriculum, and testing and make recommendations for improving these components to ensure that New York students have the opportunity to receive the highest quality education. The resulting report was intensely critical of the emphasis that the Common Core Standards place on standardized testing and recommended a more holistic approach to education.

Minimum Wage: Fight for \$15



BALCONY has long been committed to raising the minimum wage, which, at its current level, leaves millions of New Yorkers in poverty, or at best, struggling just to make ends meet.

Our new **BALCONY Co-Chair Andrew Pallotta**, Executive Vice President of the New York State United Teachers, has been vocal in his support of the "Fight for \$15."

On Monday, January 4, 2015 Governor Cuomo launched the Mario Cuomo Campaign for Economic Justice to push for the \$15/hour minimum wage. The announcement came just days before a State Senate session in which the question of whether to pursue the wage increase was near the top of the agenda. The session drew a large crowd of advocates for the increase that included members of business and labor, as well as faith based organizations.

Governor Cuomo's push to raise the minimum wage has won the backing of more than three dozen downstate business leaders. One of the first prominent business members to commit her support was **BALCONY** Executive Board Member, President and CEO of Tigress Financial, and Chairperson of the Greater New York Chamber of Commerce **Cynthia DiBartolo**. DiBartolo recently submitted testimony in support of the proposal saying, "The \$15 minimum wage proposal is a step in the right direction. An increased minimum wage is the right move for businesses and workers alike while preserving the social contract and building a just society." For DiBartolo's full testimony click [HERE](#).

Health Care: The Affordable Care Act Under Fire and the Need to Bolster Workers Safety



BALCONY has long been an advocate of universal health care. In fact, in 2010, Kathleen Sebelius, then United States Secretary of the Department of Health and Human Services, made **BALCONY**'s event on affordable health care her first appearance after the Affordable Care Act was signed by President Barack Obama. **BALCONY** continues to believe that the Affordable Care Act, which enrolled 11.7 million Americans in 2015 and 17.6 million Americans to date (according to a September report from HHS), represents a critical step forward in the struggle to ensure all Americans have adequate health care and urge our members to support it going forward.

As you are likely aware the Affordable Care Act has been under considerable attack in 2015. One of the most insidious attempts to undermine the Act are efforts (led in large part by Republican Senator Marco Rubio) against the risk corridor provision of the health care law which protects insurance companies from losses they may sustain as a consequence of signing on to the exchange. The end result is distrust and animosity between insurance carriers and the federal government and diminished enthusiasm and incentive for carriers to join the exchange.

Workers' Health and Safety

As New York prepares to move forward with several major infrastructure and construction projects in 2016 including the \$20 billion Gateway Tunnel Project thousands of construction workers will be employed in dangerous and potentially life-threatening positions. **BALCONY** is committed to ensuring



that every precaution is taken to ensure that those employed are both qualified and well-trained. Working alongside our partners and members, including Mt. Sinai's Selikoff Center we hope to ensure that the safety of workers remains paramount as these projects proceed.

A recent report of particular note comes from the New York Times and raises serious questions about the ethics and efficacy of employing non-union labor and the general lack of oversight that leads to worker fatalities, which disproportionately affect the poor and undocumented.

Safety Lapses and Deaths amid a Building Boom in New York

The rise in deaths and injuries - mostly among undocumented immigrant laborers - far exceeds the rate of new construction. A review of every construction fatality in the past two years by The New York Times has found that many could have been, as a federal investigation into one accident put it, "completely avoidable." They usually involved smaller projects, using nonunion workers, who were often poorly trained.

Affordable Housing in New York: AFL-CIO HIT \$1 Billion Investment in NYC

At **BALCONY** we believe addressing the affordable housing crisis in New York is of critical importance. In February of 2015 **BALCONY** hosted a forum with **NYC Housing Preservation and Development Commissioner Vicki Been** and **NYS Homes and Community Renewal Commissioner and CEO Darryl Towns**. Even as NYC Mayor De Blasio's dream of a \$41 billion ten-year affordable housing plan for New York City (especially his recent zoning proposals) has come under increasing criticism from community boards and interest groups there is reason to be optimistic. A \$1 billion AFL-CIO Housing Investment Trust (HIT) investment in affordable housing in NYC and other developments make it very clear that the political will to attack this crisis is there, even if navigating the political terrain and actual logistics still presents an enormous obstacle. Among the key questions that **BALCONY** will continue to monitor are (the still vague framework of) 421(a) tax credits - used to lure developers to build low-income housing, projections for long term-employment opportunities (especially in construction), and a resolution on the question of guaranteed project labor agreements (PLA's).

AFL-CIO HIT Investment

In November \$1 Billion for NYC Affordable Housing was allocated by the AFL-CIO Housing Investment Trust (HIT) and New York City Comptroller Scott Stringer pledged to invest \$150 million of NYC pension funds into the trust. More recently the AFL-CIO HIT joined forces with the United Clergy Task Force and announced plans to invest \$300 million to build affordable housing and community centers in NYC.

That was the hope expressed at Riverside Church Dec. 12, when the AFL-CIO Housing Investment Trust and the United Clergy Task Force, a coalition of religious institutions and labor unions, announced plans to invest \$300 million to build affordable housing and community facilities at seven sites in Brooklyn, the Bronx, and Jersey City. The projects are expected to create more than 800 apartments, 1,400 union jobs, and apprenticeships for neighborhood residents.
